



## WANTED FUGITIVE OF THE MONTH -

**KYMRICK D. BANKS**

**BANKS, AGE 37, IS WANTED BY THE U.S. MARSHALS AND THE BIBB COUNTY SHERIFF'S OFFICE.**

**BANKS FACES NUMEROUS SERIOUS CHARGES, INCLUDING 11 COUNTS OF AGGRAVATED ASSAULT, 4 COUNTS OF TERRORISTIC THREATS AND ACTS, AND 1 COUNT OF FLEEING OR ATTEMPTING TO ELUDE AN OFFICER—ALL FELONY OFFENSES. HE IS ALSO CHARGED WITH 2 COUNTS OF DRIVING WHILE LICENSE SUSPENDED OR REVOKED, 2 COUNTS OF FAILURE TO OBEY TRAFFIC CONTROL DEVICES, 1 COUNT OF OBSTRUCTION, AND A HEADLIGHT VIOLATION.**

## How to Submit a Tip — Quick, Secure, Anonymous



### Use the P3 Mobile App:

Download the P3 app on iOS or Android — submit tips anywhere, anytime. Still completely anonymous.

### Submit from a desktop:

Visit [www.crimestop.us](http://www.crimestop.us) and click Submit a Tip.



### What to include (the more, the better!)

Helpful details increase the chance the tip leads to an arrest — and a reward:

- Full names or nicknames
- Exact addresses or cross streets
- Vehicle descriptions (make, model, color, plate)
- Date, time and location of the incident or sighting
- Photos, videos, or case/report numbers (if available)
- Any known associates or frequent locations

### Rewards & anonymity — what you must know

Keep your unique Tip ID. After you submit, you'll receive a tip ID — this is the only identifier used to track your tip and to claim a reward. Write it down. and follow up!

Submit your tip before an arrest is made if you want your tip to be eligible for a reward.

## BOLO- Hit & Run Fatality

A family seeks answers. \$12,000 reward for information in fatal I-75 hit-and-run.



The family of Richard Alan "Rad" Dykes is offering a \$12,000 reward for information leading to the arrest of the driver responsible for his death. On June 17, 2025, Mr. Dykes was struck and killed while working on I-75 Southbound near mile marker 109 in Dooly County. The vehicle involved is believed to be a tractor-trailer that fled the scene.

With the assistance of Macon Regional Crimestoppers, the Dykes family is asking the public for help in locating the driver and vehicle involved in this tragic incident.
