April - Significant Arrest

1. Perdue, Travis – Apprehended by the U.S. Marshal's Task Force on April 29, 2024.

The fugitive was wanted by the Crawford County Sheriff's Office for Aggravated Assault, Home Invasion-1degree, Criminal Damage to Property-2nd degree.

2. Bradshaw, Erica M. – Apprehended by the Jones County Sheriff's Office on April 25, 2024.

The fugitive was wanted by the Houston County Sheriff's Office for Sup. Ct. VOP. o/c being Poss. of Methamphetamine. At the time of her arrest, the fugitive was charged with Poss. of Fentanyl. The Houston County DA's Office rewarded an additional \$500.00 for the drug related arrest.

3. Williams, Chik Amechi. – Apprehended by the Warner Robins Drug Unit on April 09, 2024.

The arrestee had in his possession 8.8 grams of Fentanyl, valued at \$300.00, and 11.3 grams of Cocaine, valued at \$1130.00. The arrestee was charged with Sale of Schd. I or II Controlled Substance, Poss. of Schd. I Controlled Substance, Trafficking in Illegal Drugs and Parole Violation.

The Houston County DA's Office rewarded an additional \$500.00 for the drug related arrest.

4. Kinsey, Haquarius. – Apprehended by the Warner Robins Police Dept. Drug Unit on April 22, 2024.

The arrestee had in his possession 1.4 grams of Fentanyl, valued at \$60.00, and .7 grams of Cocaine, valued at \$70.00. The arrestee was charged with 3 counts of Sales of Schd. I or II Controlled Substance, 2 counts of Sale of Methamphetamine, and Poss. of a firearm or Knife during a Crime. The arrestee had in his possession a Mossberg 40 caliber handgun, valued at \$250.00.

The Houston County DA's Office rewarded an additional \$500.00 for the drug related arrest.

5. Hernandez, Luis. – Apprehended by the Warner Robins Police Dept. Drug Unit on April 23, 2024.

The arrestee had in his possession 14.4 grams of Methamphetamine, valued at \$300.00, .6 grams of Heroin, valued at \$120.00, and .2 grams of fentanyl, valued at \$20.00. The arrestee was charged with 4 counts of Poss. Manufacture Certain Controlled Substances, and Poss., Manufacturer, Distribution, or sale of Controlled Substance, Poss. of Marijuana, and Obstruction of Law Enforcement.

The Houston County DA's Office rewarded an additional \$500.00 for the drug related arrest.

April - Significant Arrest

6. McCall, Antonie. – Apprehended by the Bibb County S.O. Gang Unit on April 18, 2024. The fugitive was wanted by the Bibb County Sheriff's Office for Sup. Ct. VOP. o/c being Burglary. At the time of his arrest, the fugitive was being sought by the B.C.S.O. for Agg. Battery.

7. Dyer, Matthew. – Apprehended by the Crawford County S.O. on April 14, 2024. The fugitive was wanted by the Crawford County Sheriff's Office for Terroristic Threats & Acts, Battery, Cruelty to Children 3rd degree. At the time of arrest the fugitive was also charged with Felony Obstruction of Law Enforcement.

8. Brown, Rishard – Apprehended by the U.S. Marshals Office Task Force Office on April 10, 2024. The fugitive was wanted by the Jones County Sheriff's Office for Sup.Ct. VOP. o/c being Entering Auto, Trespassing and State Ct. VOP. o/c False Statements. The fugitive was also found to have in his poss. a Springfield 9 mm, valued at \$400.00.

9. Sutton, Shanice – Apprehended by the U.S. Marshals Task Force Office on April 10, 2024. The fugitive was wanted by the Bibb County S.O. for Burglary. This tip took months to get served, with multiple tips and one angry local business owner (victim) who could not understand why the B.C.S.O. would not go pick the fugitive up for the Burglary warrant. I did not want to say it was due to the fugitive being pregnant.

10. Ford, Gartrell – Apprehended by the U.S. Marshal's Task Force Office on April 1, 2024. The fugitive was wanted by the Baldwin County S.O. for Felony Obstruction, Felony-Theft by Taking, and Hit & Run.

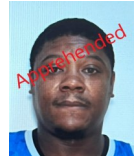
