
## Macon Regional Crimestoppers

### August - Significant Arrest

1. Poole, Larry B. – Apprehended by the Baldwin Co. S.O. on 08.27.2024

The fugitive was wanted by the Baldwin County Sheriff's Office for Parole Violation, Sup. Ct. VOP. o/c being Poss. of Firearm by Convicted Felon and Theft by Receiving Stolen Property, Obstruction of L.E., Simple Assault, and Criminal Trespass.
