For six long years, the disappearance of Damien Durrell Morren has weighed heavily on the hearts of his family and the community of East Point, Georgia. Damien, who lived with mental health challenges, vanished during the height of the COVID-19 pandemic in 2020 after a family dispute — and despite desperate efforts from loved ones, his case eventually went cold.

But thanks to the power of collaboration and the courage of a single individual, that silence is finally being broken.

A recent tip submitted through the **Macon Regional CrimeStoppers** program has reignited momentum in Damien's case. That tip — brave, detailed, and deeply meaningful — sparked immediate action. What followed was a powerful example of what can happen when communities, law enforcement, and media outlets work together toward justice.

The **Greater Atlanta CrimeStoppers**, **East Point Police Department**, and **Fox 5 Atlanta News** quickly joined forces, reviewing the new lead and launching renewed investigative efforts. Each organization brought its unique strengths: the trusted reach of CrimeStoppers, the investigative power of local law enforcement, and the influential platform of the media. Their unified effort created a ripple effect bringing the tough questions that have lingered for too long to the surface.

This is what teamwork looks like. It's not just organizations in suits and uniforms — it's also the people who pick up the phone, who take a chance on telling what they know. CrimeStoppers protects those voices and empowers them. One anonymous call can mean everything.
