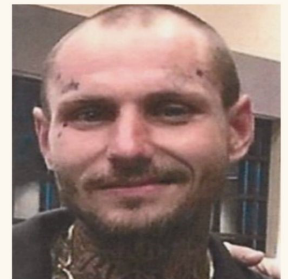

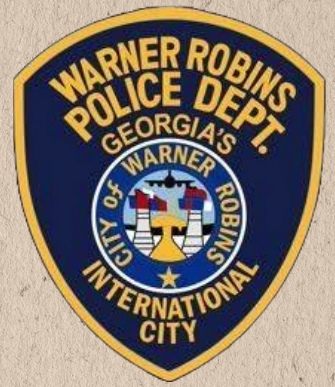

The manner of death has been ruled a homicide, and the cause of death was determined to be blunt force trauma.
