UNSOLVED HOMICIDE \$8,000 REWARD Willie "Joe" Huff III

On October 23, 2016, at 10:31 p.m., officers with the Warner Robins Police Department were dispatched to the 100 block of Ruth Court in reference to a person who had been shot. Upon arrival, they discovered that Willie "Joe" Huff III had been shot twice. He was transported to the hospital, where he later died from his injuries. According to family members, Mr. Huff had just pulled into his driveway when an argument was heard outside. Moments later, gunshots rang out. Detectives believe the suspect or suspects may have attempted to rob Mr. Huff.

This case remains unsolved, and an \$8,000 reward is being offered for information leading to an arrest. Anyone with information is urged to contact the Warner Robins Police Department Criminal Investigations Division at (478) 302-5380 or Macon Regional Crimestoppers at 1-877-68CRIME. The reward is provided by the Houston County District Attorney's Office through Macon Regional Crimestoppers. All tips can remain anonymous. Help bring justice to Willie Huff's family—make the call.

Ashton M. Fort – Case #2022-72500

On August 17, 2022, at approximately 4:34 PM, the Bibb County Sheriff's Office responded to a shooting at the intersection of Nisbet Drive, Bobby Jones Boulevard, and Springmeadow Drive in Macon, Georgia. The victim, Ashton Fort, had been shot multiple times and was transported to Navicent Health for treatment. Tragically, Ashton was pronounced dead at 9:22 PM that evening. Several investigative leads have been pursued, and while all current evidence has been processed, authorities are still seeking additional information from the public. The Bibb County Sheriff's Office and Macon Regional Crimestoppers are asking anyone who may have information about this case or those responsible to come forward. If you have any details, no matter how small, please do your part and "Make the Call." On October 05, 1993, Bula Mae Robertson was reported missing by her daughter. Ms. Robertson was last seen at her residence of 219 Peachtree Circle in Warner Robins. Ms. Robertson was known to frequent the South First St. area and "Old Town" area. The area of "Old Town" referred to to the neighborhood of Old Mission Way, Orchard Pass and Township Dr. Due to circumstances in the investigation, foul play is suspected in Ms. Robertson's disappearance. Ms. Robertson was 37 years old, 5'4 and weighed 110 lbs. when she was reported missing.
