Case Number: 2011-12-147

MISSING



Troy Burnett, a resident of Jeffersonville, Georgia, was last seen at his home on December 19, 2011. He was 47 years old at the time. Burnett was reported missing two days later by his mother, Ida McClinton, after he failed to return home. His family expressed immediate concern due to his medical condition—Burnett was taking medication for seizures, and without it, he was known to hallucinate.

Prior to his disappearance, Burnett had made statements about possibly traveling to New Jersey or concerns about being placed in a nursing home. The last confirmed sighting came from his aunt, Robbie Rouse, who saw him walking along Gallimore Mill Road. He was well known in the Jeffersonville community for walking or riding his bike around town and was often seen engaging with neighbors and friends. At the time he went missing, Burnett was described as a Black male, approximately 5'8" to 6'0" tall, weighing between 160 and 170 pounds, with short black hair and brown eyes. He was last seen wearing blue jeans, a blue shirt, and a tan coat.

To this day, his family continues to search for answers, holding on to hope that someone, somewhere, knows what happened. If you have any information—no matter how small—that could help in locating Troy Burnett or explaining the circumstances of his disappearance, please come forward. Your tip could finally provide the closure his loved ones have been desperately waiting for.

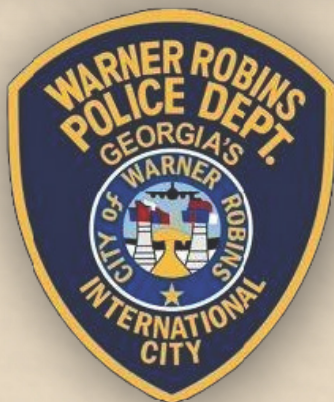

UNSOLVED HOMICIDE \$8,000 REWARD Christie C. Douglas



On March 28, 2016, Christie Douglas was reported missing by her family. She was last seen in the area of Ravenwood Way in Warner Robins on March 16, 2016. Christie was wearing a short sleeve shirt (UNK Color) and blue jeans. She was carrying a denim tote bag and a green gym bag. Christie is 5'1 and weighed 120 lbs. when she went missing. She was 45 years old at the time of her disappearance.

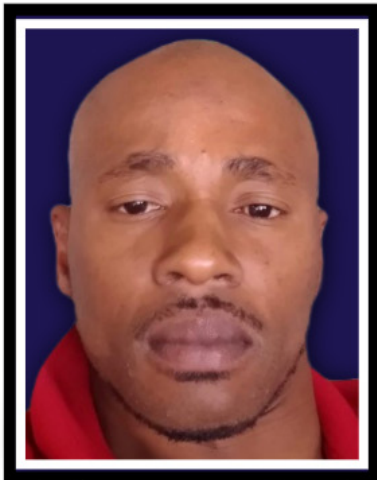

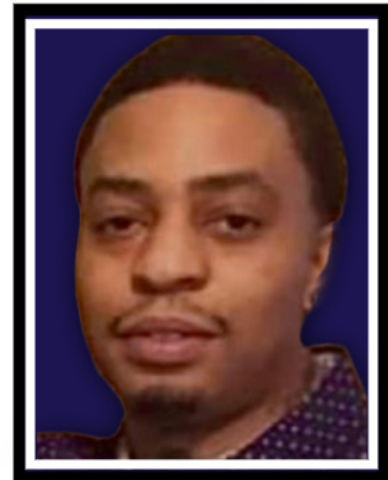

Milledgeville, GA – On July 3, 2021, at approximately 2:30 a.m., officers with the Milledgeville Police Department were dispatched to the 2300 block of Laura Court in reference to a shooting. Upon arrival, officers discovered three victims—Erica Reaves, Tyric Justice, and Quincey Jackson—suffering from multiple gunshot wounds. Ms. Reaves and Mr. Justice were pronounced deceased at the scene, and Mr. Jackson later succumbed to his injuries at the hospital.

Since that tragic night, the Milledgeville Police Department has remained committed to bringing justice to the victims and their families. Over the past several months, MPD detectives have conducted new interviews and are working closely with the Georgia State Crime Lab to analyze recently submitted DNA evidence. These efforts are part of our continued pursuit to identify those responsible and hold them accountable.
