

Wanted in Bibb, Caught in Tennessee: Tipster Helps Close the Distance

Daymien L. Raymond, Sr., a Crimestoppers Featured Fugitive wanted out of Bibb County, Georgia, has been taken into custody in Tennessee following a successful multi-agency effort triggered by an anonymous tip.



Raymond, age 32, had been living in Harriman, Tennessee, while wanted in Georgia on a long list of serious charges:

- Sup. Ct. VOP. - Aggravated Assault, Terroristic Threats and Acts, Criminal Trespass and Criminal Damage to Property
- Sup. Ct. VOP. - Terroristic Threats and Acts, Criminal Trespass and Simple Battery F/V
- Sup Ct. B.W. - Terroristic Threats and Acts, Criminal Trespass and Simple Battery F/V
- St. Ct. VOP. - Driving Without a Valid License

Thanks to the vigilance of our community tipsters and the interagency collaboration that defines our mission, this individual is now in custody and will be returned to Bibb County to face prosecution.

ANONYMOUS TIP LEADS TO ARREST OF VIOLENT FUGITIVE BY U.S. MARSHALS

MACON, GA — Thanks to a vigilant tipster, a dangerous fugitive is now behind bars. Early this morning, the U.S. Marshals Office apprehended Jerry Tyro Briscoe at a residence located at 4397 Mikado Avenue, Macon, GA, following a tip submitted through the Crimestoppers program.

The Crimestoppers program is built on anonymity and community trust. When someone contacts us with information about a crime or the whereabouts of a wanted individual, we never ask for their name, and we never know who they are. Tipsters remain completely anonymous from start to finish. Our role is to take the information they provide, verify its value, and pass it along to the appropriate law enforcement agency. From there, officers and investigators do what they do best—make arrests, recover evidence, and bring justice to our communities. It's a simple but powerful system where everyday people can help make a real difference—safely and anonymously.

Briscoe was wanted by the Bibb County Sheriff's Office for multiple felonies, including 1 Count of Murder; malice murder; felony murder; murder in the second degree, 1 Count of Trafficking in cocaine, illegal drugs, marijuana, or methamphetamine, 1 Count of Possession of firearms by convicted felon and first offender probationers, 1 Count of Possession of firearm or knife during commission of or attempt to commit certain crimes.

Briscoe also has active warrants out of Jones County and is currently being held for those charges as well.

On April 30, 2023, at approximately 2:00 a.m., Morray A. Ross was shot and killed on Camellia Boulevard in Fort Valley, GA.

Morray had just turned 20 years old two days prior. His life was cut short in a senseless act of violence, and the person or persons responsible have yet to be brought to justice.

The Fort Valley Police Department continues to investigate, but they need the community's help to move this case forward.

UNSOLVED HOMICIDE \$8,000 REWARD Clarence D. Hardison


On January 23, 2001, at approximately 6:00 P.M., 49-year-old Clarence Darnell Hardison was found beaten and strangled to death inside his home at 102 Sun Valley Drive in Warner Robins, Georgia.

The residence had been ransacked, and robbery is considered a possible motive. Mr. Hardison was a construction worker by trade and was known to be a kind, hard-working man.

This case remains unsolved after more than two decades, and authorities are still actively seeking leads that could help bring closure to Mr. Hardison's family.

Ormanda C. Clark – Case #2022-40955

On May 16, 2022, Ormanda C. Clark was last seen at 418 Chappell Street in Macon, Georgia. Later that same day, Clark was ambushed by several unidentified male suspects and sustained multiple gunshot wounds.

Detectives with the Bibb County Sheriff's Office have conducted a thorough investigation, including the completion of several search warrants, and the pursuit of multiple investigative leads. Despite these efforts, the case remains open and unresolved.

The Bibb County Sheriff's Office, in partnership with Macon Regional Crimestoppers, is seeking information from the public. Even the smallest detail could assist in identifying those responsible for Clark's death.

All tips remain anonymous, and individuals may be eligible for a reward if their information leads to an arrest.
